Record of Discussion of the 22nd DPIIT Level Committee Meeting held on 27th May 2026 for considering application for registration of the units under Uttar Poorva Transformative Industrialization Scheme (UNNATI, 2024)

1. The 22nd DPIIT Level Committee (DLC) meeting was held under the chairpersonship of Dr. Kajal, Joint Secretary DPIIT, on **27th May 2026 at 11:00 AM**. The meeting was held in hybrid mode to consider applications for registration of units under the UNNATI scheme. The list of participants is enclosed in **Annexure I**.

2. 39 applications (Assam-35, Nagaland-2 & Sikkim-2) were submitted for consideration before the DLC. The applications were recommended in the SLCs conducted by the respective State Governments for further consideration by the DLC for grant of registration under UNNATI, 2024.

3. After detailed deliberations, the **Committee approved grant of registration** in respect of **Twenty-nine (29)** units under UNNATI, 2024 (**listed at Annexure II**).

It is pertinent to mention that following is to be considered while processing the claims of the above units:

As per clause 8.7 of the UNNATI scheme notification dated 09.03.2024, the final invoice for procurement of Plant and machinery or for construction of buildings and durable physical assets must be on or after 09.03.2024 to be considered eligible under the scheme. The Committee recommends that the claim applications be thoroughly checked for all relevant bills and vouchers as per the guidelines.

As per clause 8.2, manufacturing sector units with a minimum investment of Rs. 1.0 crore in plant & machinery will be eligible for incentives under this scheme. For calculation of any incentive under the scheme the eligible value shall be determined based on the investment made in Plant & Machinery in manufacturing sector. The scheme shall not apply to the units that manufacture the products listed in the Negative list in Annexure –I.

8.3. Service sector units with a minimum investment of Rs. 50 Lakh in building and other durable physical assets will be eligible for incentives under this scheme. For calculation of any incentive under the scheme the eligible value shall be determined based on the investment made in building and other durable physical assets. The scheme shall be applicable only for services listed in the Positive list in Annexure-II.

8.4. For Micro Industries the minimum investment limit shall be Rs. 50 lakhs for both manufacturing and service sectors.

4. After due scrutiny, the Committee directed to seek **necessary clarification in r/o five applications (05)** for registration (**listed at Annexure III**).

5. **Five (05)** applications have been **rejected** for registration approval (**listed in Annexure IV**).

6. **Further, Forty-eight (48) applications** pending at applicant level for more 90 days were also placed for **rejection**. As per the clause 11 of the General Operational Guidelines for Registration of Units under Unnati, 2024:

“The states will have a 3-months timeline to process the registration application and recommend it to DPIIT for decision. In case of pendency beyond 3 months, the application shall be considered “deemed recommended” by the state and eligible for consideration at the DPIIT

level. For all such applications, the committee at the DPIIT shall do its due diligence through PMU/PIU.”

Thus, **48 applications were rejected** in line with Clause 11 of the General Operational Guidelines for UNNATI, 2024, which mandates a 3-month processing timeline, applications pending at the applicant level for more than 90 days, due to non-submission of required documents or repeated correction cycles. **(listed in Annexure V)**. The audit trail regarding communications sent to the applicant through portal is attached in annexure V.

7. All food processing units and tea manufacturing units granted registration under UNNATI shall be cross verified with the Ministry of Food Processing Industries and the Tea Board to ensure that no duplication of incentives occurs.

8. The Committee has sought clarification from the State Government of Assam regarding the delay in forwarding the following two applications:

(a) *M/s Dhan and Rani Tea Industry* (Application No. NER/2024/00087), submitted on 24.04.2024 and forwarded to DPIIT on 22.04.2026; and

(b) *Bamunjuli Chai Udyog Private Limited* (Application No. NER/2024/00327), submitted on 01.07.2024 and forwarded to DPIIT on 22.04.2026.

The State Government of Assam is also requested to furnish reasons for the inordinate delay in processing and forwarding the above applications.

9. The Committee observed that a significant number of applications have been pending at the State level for a considerable period, thereby impeding the project pipeline. In this regard, the Chair instructed that monthly review meetings be convened with the concerned State-level Directors to assess the status of pending applications and to seek necessary directions from the Chair for expeditious processing.

10. The Committee noted that the Ministry of Development of North Eastern Region (DoNER) has empanelled Chartered Accountants for facilitating applicants. In this regard, it was directed that the same may be hosted on the UNNATI portal, along with an appropriate disclaimer clearly stating that DPIIT does not assume any responsibility for the services rendered by the empanelled Chartered Accountants.

11. The Committee directed the State that all clarifications sought in applications, as per *Annexure III*, shall be responded to within a period of 30 days of issuance of the minutes. It was further instructed that failure to furnish the requisite responses within the stipulated timeline shall result in rejection of the concerned applications.

12. It was also instructed that applications pending at the applicant level for more than 30 days shall be automatically forwarded to DPIIT for rejection. However, the State Government shall adhere to the prescribed SOP, which requires issuance of a public notice in newspapers regarding the rejection of such applications.

The Meeting ended with a Vote of Thanks to the Chair.

*** The Committee approved the registration for **Aurora Mechprint LLP** and **Sethia Industries Private Limited** with a condition that the unit shall submit the registered lease deed within six months of grant of registration, failing which the unit shall be liable for de-registration and shall become ineligible for claims under the UNNATI, 2024 Scheme.*
